# Cornwall Beekeepers' Association (CBKA) 2025 Membership Application / Renewal Information

## Introduction

As a new or existing member planning your membership, we look forward to welcoming you to the Cornwall Beekeepers' Association (CBKA) for the 2025 season.

The CBKA is a registered charity whose aims are to promote, sustain and increase individual and collective knowledge of apiculture in the County of Cornwall. They will;

- a) Promote and further the craft of beekeeping, by educating beekeepers and prospective beekeepers in apiculture;
- b) Advance the education of the public in the importance of the honey bee in the environment.

We regularly exhibit at the main agricultural shows in the Duchy and receive a great reception from the general public.

Our education programme continues through our own meetings and events, attended primarily by members of the CBKA but also open to members of the public who are interested in joining. We hope that this encourages more people to take up the craft who will then attend regularly and then join and support the CBKA.

At group meetings of the CBKA a wide range of topics are covered – in the winter these tend to be an opportunity to learn new techniques, about new threats or opportunities and to exchange views. You are free to attend any CBKA group events as you wish in addition to your own local one.

In the warmer months these may take place in group or member's apiaries where you are able to "have a go" and gain practical experience and share knowledge. More experienced beekeepers are able to pass on their knowledge and it gives new members a great forum to try out handling bees and to ask questions.

### **BeeCraft Magazine**

BeeCraft Subscriptions are now managed directly by BeeCraft.

If you currently subscribe you will receive communications direct from them to renew.

If you wish to subscribe for the first time, then you will find a special promotion code on your membership receipt when you join or renew, so that you can manage this yourself via the BeeCraft website.

You can also set up Direct Debit Payments ensuring that your BeeCraft subscription renews automatically and receiving an even greater discount.

### **Bee Disease Insurance (BDI)**

CBKA Full membership automatically includes BDI cover for your first 3 colonies.

**Please note the terms of the Insurance below:**

For new or renewal subscriptions after 31<sup>st</sup> January 2025 a 40-day waiting period from your application exists before cover is effective.

“Where, at the time of an inspection by a duly authorized Bee Inspector, the number of colonies managed exceeds the number of colonies for which the premium has been paid, no cover will apply under this policy. (When determining the number of colonies to insure potential increase must be taken into consideration)”.

Members must therefore indicate on the membership form the number of colonies they are likely to be operating during the membership year, including nucleus colonies. Additional insurance is available. It is advisable for members to insure for one level above the level operated at the start of the year. It is the responsibility of the member to predict the number of colonies likely to be operated throughout the season.

## Additional BDI Premium Rates for 2025 – unchanged since 2023
